ORDER: -

In the reference 4th and 5th cited, the Grant-in-aid of Sri Ramakrishna Degree College, Nandyal, Kurnool District run by Sri Ramakrishna Educational Society, Nandyal, Kurnool District was withdrawn. Hence, the Sri Ramakrishna Degree College, Nandyal, Kurnool District is now a Private Un-aided Degree College for all purposes.

In accordance with the provisions under Section 20 of AP Education Act 1982 and the Rules framed thereon under reference 3rd cited, the Sri Ramakrishna Degree College, Nandyal, Kurnool District requires the administrative approval for functioning as Private Unaided Degree College and to offer unaided courses /programmes at Under Graduate and Post Graduate levels.

Sri Ramakrishna Educational Society, Nandyal, Kurnool District managing Sri Ramakrishna Degree College, Nandyal, Kurnool District vide reference 7 has applied for approval of the APSCHE, which is the Competent Authority to function as Private Unaided Degree College, from the academic year 2021-22, and in accordance with the notification under reference 6th cited.

After duly examining the proposal submitted by the institution and in exercise of powers vested in it vide reference 2nd cited, the A.P State Council of Higher Education hereby accords provisional recognition orders from the year 2021-22 to the college mentioned hereunder and to offer the following unaided UG and PG programmes from 2021-22:

The provisional recognition accorded is subject to fulfillment of the following conditions:

- 1 The Management / College shall fulfill the following deficiencies within a period of one month and send compliance along with documentary evidence to APSCHE, failing which, APSCHE has the authority to withdraw its approval.
 - a. Sketch plan of the own land to be submitted
 - b. College building plan details to be submitted
 - c. Approved building plan to be submitted
 - d. Building construction permission order to be submitted
 - e. Parking & Playground details to be submitted
 - f. Latest sanitary certificate to be submitted
 - g. Corpus fund details of the college to be submitted
- 2 The staff engaged should be qualified as per the rules and regulations issued by Govt/Council/UGC.
- 3 The management shall follow the rules issued by the Government / Competent Authority from time to time on all aspects related to the administration of the college.
- 4 Infrastructure like Buildings, Land, Playground, Lab equipment, Library, Furniture etc., should be well maintained for the effective functioning of the College.
- 5 The management should not make any claim from the Govt. / Council or any other Govt. agency for any grant-in-aid either now or in future.

- 6 The College (a) should not be shifted to any other place; (b) should not change the name of the College, (c) should not transfer the management of the College and (d) should not convert Women's College to Co-Education and vice-versa without prior permission of the AP State Council of Higher Education/Government of Andhra Pradesh.
- 7 The accommodation shown for Degree College should not be used for any other purpose other than running the degree college for which permission is given by the APSCHE.
- 8 The management should not change the Courses / Combinations, intake and media sanctioned in these proceedings failing which, such action will be construed as tampering of records for which APSCHE will initiate necessary legal action against the Management.
- 9 The management of the College shall set up a grievance and complaints cell as per the Supreme Court / UGC guidelines for dealing with sexual harassment / ragging related cases and other grievances etc.
- 10 The management of the College shall not affiliate itself to any University outside the State of Andhra Pradesh and run the courses of other State University in their premises under Section 21-A of A.P. Education Act 1982, failing which, the Managements shall face criminal action under Section 21-A of AP Education Act.
- 11 The management should establish a website for the college and keep all the necessary academic and administrative information in the website.
- 12 APSCHE reserves the right to conduct surprise checks at any time. The Council also reserves the right to cancel permission / affiliation of the college at any stage, if it is found that the documents produced by the management are false, interpolated and improper and the management is not able to run the college as per the norms of the Government and academic stipulations of the concerned University, apart from any defaults/ irregularities committed which would attract legal proceedings under Law.
